13. EMPLOYEE DISCOUNT SERVICE

13.1 PURPOSE AND APPLICABILITY

This section is applicable for employees of SureWest TeleVideo or any SureWest affiliate during the term of active employment and who subscribe to SureWest TeleVideo services as described below.

13.1.1 AVAILABLE SERVICES AND RATES

- (A) EMPLOYEE LOCAL SELECT PLAN \$13.00 per month

This plan includes a Residential Basic Phone Package (flat-rate local calling) Caller ID Blocking, and a choice of Basic Voice Mail with Single Access and any three of the available custom calling features, or any five of the available custom calling features (without Voice Mail). Terms and conditions for this plan can be found in this Tariff Schedule, Section 3.4.1(I).

- (B) EMPLOYEE CALIFORNIA UNLIMITED
SELECT PLAN \$18.00 per month

This plan includes a Residential Basic Phone Package (flat-rate local calling), Unlimited Long Distance Calling to anywhere in California, Caller ID Blocking, and a choice of Basic Voice Mail and any three of the available custom calling features, or any five of the available custom calling features (without Voice Mail). Terms and conditions for this plan can be found in this Tariff Schedule, Section 3.4.1(I) and in SureWest TeleVideo Long Distance Tariff Schedule Cal. P.U.C. No. 3-T, Section 3.4.1(C)(4).

- (C) EMPLOYEE NATIONAL UNLIMITED
SELECT PLAN \$20.00 per month

This plan includes a Residential Basic Phone Package (flat-rate local calling), unlimited nation-wide calling, Caller ID Blocking, and a choice of Basic Voice Mail and any three of the available custom calling features, or any five of the available custom calling features (without Voice Mail). Terms and conditions for this plan can be found in this Tariff Schedule, Section 3.4.1(I) and in SureWest TeleVideo Long Distance Tariff Schedule Cal. P.U.C. No. 3-T Section, 3.4.1(C)(5).

13.1 PURPOSE AND APPLICABILITY – (Cont'd)

13.1.2 SPECIAL CONDITIONS

- (A) Employee Discounts are not available for any telephone features or services beyond what is described in this section. Tariffed discounts on services not offered as an Employee discount would still apply.
- (B) If an employee wishes to upgrade from Basic Voice Mail to Enhanced Voice Mail, there is an additional charge of \$1.00 per month.
- (C) Installation charges are not eligible for Employee Discount. All applicable Non-Recurring Charges and/or installation charges will apply at the applicable tariff rate.
- (D) Employee Discount Service may apply to additional lines within the same household for the services listed in this section.
- (E) Employees subscribing to any of the available service offerings in 13.1.1 above that also subscribe to SureWest's video service will receive an additional discount of \$11.00 per month per subscriber off the Employee Discount Service rates.
- (F) Employees participating in the Employee Discount Service agrees to electronic notification to a specified e-mail account of the online availability of their monthly bill statement. A paper bill will not be provided to employees participating in Employee Discount Service.
