18.3 SPECIAL CONDITIONS

(A) LIMITATIONS

- (1) This service is furnished where operating conditions and the availability of facilities permit.
- (2) The DID trunk terminating equipment provides a feature which allows an incoming call from the exchange network (not Foreign Exchange or WATS) to reach a specific station line without an attendant's assistance.
- (3) The satellite operation feature is required to provide digit translation when the central office sends a different number of digits than required for the CBX station numbering plan, such as DID service.
- (4) Direct inward dialing service must be provided on all lines in an exchange trunk group arranged for inward service.
- (5) Additional numbers or spare numbers reserved for future growth will be furnished and billed for in blocks of 20 or 100 at the charge and rate set forth above and as selected by the customer. (C)

- (6) Direct inward dialing station numbers may be listed in the directory at charges, rates and conditions as set forth in Cal. P.U.C. Schedule A15, "Directory Listings."
- (7) Intercepting of numbers assigned to the customer that are vacant or not in use by the customer is the responsibility of the customer. Attendant or suitable machine intercept shall be arranged in customer-provided switching systems.

(B) RATE REGULATIONS

- (1) The charges and rates herein contemplate the use of Utility-provided Central Office switching equipment and serving arrangements. When equipment or service of a special type is requested and provided, charges and rates based on costs involved to meet the individual requirements of each case will be made subject to prior authorization of the California Public Utilities Commission.
- (2) The basic termination charge for this service is based on the number of years in the customer-selected plan and will be reduced by one thirty sixth (1/36) for each full month from the in-service date of the direct inward dialing service. Should a reduction in the service be requested, the last equipment arrangement provided will be considered to be the first removed. (C)
