4.1 ALTERNATE BILLING (Pathfinder™)

4.1.1 DESCRIPTION

Pathfinder™ Billing will provide a copy of the Utility's monthly billing on a compact disk (CD). Pathfinder™ Billing contains reports to allow analysis of call data and macro generators that will allow a customer to build standard reports and line descriptions that can repeatedly run.

4.1.2 RATES

4.1.3 SPECIAL CONDITIONS

(A) DESCRIPTION

- (1) Single Line Account - Customers with single location, bill and access type.
- (2) Consolidated Bills - Customers with same or multiple locations and service access types who request one bill instead of an individual bill for each location and service access type.
- (3) Stacked Bills - Customers with same or multiple locations and service access types who request each bill remain as an individual bill.

(B) LIMITATIONS/REGULATIONS

- (1) Pathfinder™ Billing will be established and/or discontinued effective with the next bill round date following the customer request. The fixed monthly rate will not be prorated as it is applied on a per compact disk basis.

(B) LIMITATIONS/REGULATIONS (Cont'd)

- (2) Rendering and payment of bills will be furnished in accordance with Schedule Cal. P.U.C. No. A2.1.9, "Rendering and Payment of Bills."
- (3) Late payment charges as set forth in Schedule Cal. P.U.C. No. A28.2.1 apply.
- (4) Pathfinder™ Billing is available on single line accounts, consolidated bills, or stacked bills. These services may not be combined on a single compact disk.
- (5) Pathfinder™ Billing is not available on Non Mechanized (Manual Bills), Political Campaign Accounts, and 900/976 Information Providers.
- (6) Pathfinder™ Billing is not produced on revised final billing.
- (7) Billable call detail is only available for calls placed through Interexchange Carriers and billed by Roseville (e.g. casual and invoice ready billing)
- (8) Pathfinder™ Billing is available with the exchange served by a central office where facilities and operating conditions permit.
- (9) Customers who purchase Pathfinder™ Billing will have the option of discontinuing receipt of paper bills.
